

Resolution Allocating Funding for the 2nd Street Reconstruction Project.

AMENDED RESOLUTION

WHEREAS, there is a need to reconstruct a portion of 2nd Street from State Street to Jay Street to provide improvements such as replacing the pavement, addition of a raised pedestrian intersection crossing at the crosswalk at 2nd Street and Pearl Street and minor sidewalk reconstruction on the east side of 2nd Street from Pearl Street to Main Street; and

WHEREAS, this reconstructed portion of 2nd Street shall be designed and constructed to accommodate a future 2-way cycle track; and

WHEREAS, there are also utility adjustments and replacements anticipated; and

WHEREAS, there is a desire to complete this project prior to the opening of the La Crosse Center in September 2021; and

WHEREAS, the City has received a cost estimate for this project to be ~~\$1,430,024~~ \$1,470,021, which includes design compensation and construction administration, construction, ~~and 10% contingency and design of a 2-way cycle track on 2nd Street from Oktoberfest Strasse up to the Market Street bridge; and.~~

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of La Crosse that funding in the amount of \$1,474,000 be allocated for the 2nd Street reconstruction project.


BE IT FURTHER RESOLVED that the cost of these projects is hereby appropriated and ordered paid out of the following:
