ORDINANCE NO.:5286  
AN ORDINANCE to amend secs.  
40-175, 115-80, 115-342(b)(1) of the  
Code of Ordinances of the City of La  
Crosse regarding property owner  
notifications.  
THE COMMON COUNCIL of the  
City of La Crosse do ordain as  
follows:  
SECTION I: Section 40-175 is  
hereby amended to read as follows:  
Sec. 40-175. - Property owner  
notification.  
In addition to the notification  
requirements contained in Wis.  
Stats., §66.1003, all public way  
vacations shall require written noti-  
fication by regular mail to the owners  
of record of land within a ~~200~~ 300  
feet radius ~~excluding right-of-way~~  
of the proposed vacated land.  
SECTION II: Section 115-80 is  
hereby amended to read as follows:  
All rezoning amendments, except  
as otherwise provided by the Com-  
mon Council for comprehensive  
rezonings, shall require written noti-  
fication by regular mail to the owners  
of record of land included in such  
change located with ~~200~~ 300 feet  
radius ~~excluding right-of-way~~.  
SECTION III: Section 115-342(b)(1)  
is hereby amended to read as  
follows:  
(1) Name and address of the  
applicant, owner of the site, archi-  
tect, professional engineer, contrac-  
tor and all owners of record within a  
~~200~~ 300-foot radius ~~excluding right-~~  
~~of-way~~ and said record owners shall  
be notified of the application not less  
than seven days prior to the  
Judiciary and Administration Com-  
mittee Meeting.  
SECTION IV: Should any portion of  
this ordinance be declared unconsti-  
tutional or invalid by a court of  
competent jurisdiction, the remainder  
of this division shall not be affected.  
SECTION V: This ordinance shall  
take effect and be in force from and  
after its passage and publication.
