feat radius excluding right of way of the proposed vacated land. SECTION II: Section 115-90 is

(1) Name and address of the applicant, owner of the site, architect, professional engineer, contractor and all owners of record within a 200 300-foot radius excluding -ight-of-wey and said record owners shall be notified of the application not less than seven days prior to the Judiciary and Administration Committee Meeting.

SECTION IV: Should any portion of this ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of this division shall not be affected.

SECTION V: This ordinance shall take effect and be in force from and after its passage and publication.
