- [2649](#) An appeal regarding the requirement to provide a 20 foot rear yard setback and an appeal to the requirement to provide 15 feet of perimeter fill around an addition at 712 Cliffwood Ln., La Crosse, Wisconsin.
- [2650](#) An appeal regarding the requirements that fill around the perimeter of a building shall be not less than one foot below the flood protection elevation and shall extend at least 15 feet beyond the limits of any structure at a property known as 2829 Hamilton St., La Crosse, Wisconsin.
