Dear City of La Crosse City Council,

I am writing in support of the proposed ordinance to ban conversion therapy in the city of La Crosse. Historically conversion therapy is based on the belief that homosexuality is a mental illness that needs to be cured, a belief that has been found to be scientifically invalid in the mental health professional community. This proposed ordinance would protect the health of lesbian, gay, bisexual, and transgender (LGBT) people from harmful and ineffective change efforts.

In 1973, the American Psychiatric Association removed homosexuality from the Diagnostic and Statistical Manual, which is the standard classification of mental disorders used by mental health professionals. As a result, it is unethical for mental health practitioners to attempt to fix or cure LGBT people through the use of sexual orientation or gender identity change efforts. The practices that are used to "convert" or "repair" a LGBT person are based on theories with questionable scientific validity and which have not produced any rigorous scientific evidence to prove their claims of a cure.

By banning conversion therapy, the city of La Crosse would join more than 46 national and international organizations and thirteen other Wisconsin cities that have spoken out against this harmful form of therapy (see attached list).

As a licensed psychologist in Wisconsin since 2007 and as member of the World Professional Association for Transgender Health since 2009, I offer my strongest support for this ordinance banning the practice of conversion therapy in the city of La Crosse.
