Good evening, City Council Members,

I recently read the City of La Crosse Judiciary and Administration proposal and vote to ban conversion therapy for sexual orientation and gender identity. I have also read the editorial letter that Dr. Van Wyk has sent you and while I respect Dr. Van Wyk as a colleague, the information she has shared with the committee is outdated and incorrect.

As the co-founder and medical lead for the Pediatric Gender Clinic at Gundersen Health System in La Crosse, I am enthusiastically in support of banning conversion therapy for sexual orientation and gender identity. I am happy to also share with you the most recent research in the field, based on numerous research studies and articles with the most upto-date information possible at your request. Referring to the ordinance 22-063 Section 32-191 (a) (2), the well-documented, prevailing opinion by medical and psychological communities that conversion therapy is ineffective and causes serious emotional distress that can lead to psychological trauma has been very well-established and I will not reiterate all of the medical literature that pertains to such findings. I will, however, reiterate the importance of providing safe spaces for young individuals to explore their gender identity and sexual orientation without detrimental influences that can cause long-term damage and psychological harm.

The American Academy of Pediatrics (AAP) is a professional organization of over 67,000 pediatricians and has created a Section on LGBT Wellness, which I am a member of. This Section on LGBT Wellness continues to review the most up-todate literature and research on LGBTQ+ health, informing the AAP's policy statements to help ensure that all children are safe. In a Recent policy statement from October of 2018, titled "Ensuring Comprehensive Care and Support of Transgender and Gender Diverse Children and Adolescents" (Pediatrics, Volume 142, Issue 4), authors appropriately state: ""Conversion" or "reparative" treatment models are used to prevent children and adolescents from identifying as transgender or to dissuade them from exhibiting gender-diverse expressions. The Substance Abuse and Mental Health Services Administration has concluded that any therapeutic intervention with the goal of changing a youth's gender expression or identity is inappropriate. Reparative approaches have been proven to be not only unsuccessful but also deleterious and are considered outside the mainstream of traditional medical practice. The AAP described reparative approaches as "unfair and deceptive." At the time of this writing,* conversion therapy was banned by executive regulation in New York and by legislative statutes in 14 other states as well as the District of Columbia." A similar statement was made by the American Medical Association in 2019, the American Academy of Child and Adolescent Psychiatry in 2018, as well as the American College of Physicians in 2015. As you can see, these views are not new. These statements from our governing medical bodies are based on hundreds of studies. The statistics that Dr. Van Wyk shared with you was based on a handful of articles that have significant validity concerns and have since been heavily scrutinized within the medical community, as their findings have not been consistent with the current medical literature based on robust data from multiple medical institutions worldwide. I believe her intent was to spark community dialogue, but I also think it is important to remind ourselves that our children and community deserve evidence-based, gender-affirming care through inclusive, supportive medical and mental health teams. Also, I believe that she was making the inference that all professionals who attempt to question a child's gender identity would be seen as attempting conversion therapy and would possibly be arrested, but if you look at the data in other states, it just prevents children from being exposed to mental health providers with harmful biases that lack of developmentally appropriate, open exploration of sexual orientation, gender identity, and/or gender expression, without any pre-determined outcome. Trained professionals who build therapeutic relationships have the ability to provide gender-affirming care, which (by definition), allows youth and adults to have safe spaces to explore their gender and sexuality without judgement and without a solitary outcome. Gender-affirming, inclusive mental health support

creates structure and safety for diving into one's behaviors, as well as the nuances of all their identities, emotions and trauma. As a pediatrician who works with many LGBTQ+ youth in our community, there are many ways we can affirm someone's gender that have nothing to do with hormones or surgeries. These families are looking for evidence-based education, support for their child and judgement-free spaces to ask questions, while their children are looking for spaces where they can just be themselves.

Dear Mayor Renolds,

I see that there is a group of persons that are asking you to veto the 'ban on conversion therapy' which the judicial committee passed.

I am going to say I am an ally for the transgender community up front to be transparent.

I have investigated and researched what it means to be transgender for more than 10 years to try and understand why these persons

are an issue. I have come to the conclusion that they are no more an issue than left-handed persons. Not so long ago, before we knew

the scientific/medical/genetic reasons for the difference, we persecuted them and tried to train, teach and sometimes tortured them all because they were different.

I could give other examples, but the issue here is the difference between what we were taught based on old outdated knowledge of genetics and medicine.

Most persons were taught there are only XX and XY persons, when because we now can see DNA and its' components, we know that is not true.

We know there are Chimeras, persons with two sets of different DNA. We know that there are *guevedoces*, persons born with female external genitalia, but when reaching puberty

because of testosterone naturally produced, they grow male external genitalia.

We also know that changing just one tweak of one gene can cause male mice to grow ovaries. What is to say that this type of tweak can occur by natural phenomenon

in humans. 1000s of other tweaks occur causing things like albinism, Autism, Downs syndrome, Hemophilia and Progeria to name just a few caused by mutations in the DNA.

My research has led me to the NIH Human Genome Research Institute, where they are working on locating the gene, protein or combination in human DNA which can

To Mayor Mitch Reynolds,

I see the protestors outside City Hall and I weep. I beg you to pass the ordinance that bans conversion therapy in La Crosse. Please allow me to tell you the story that has my gut in knots right now.

I am a follower of Jesus Christ. The God of my faith has helped me through many dark valleys in the past, continues to speak to me today, and will always be there for me in the future. I consider it a miracle that I still have any faith at all considering the abusive spiritual practices I've both survived and witnessed. These abuses have directly resulted in one death.

Katie was my friend. She was innocent, compassionate, and goofy. She spent most weekends either riding her horse or singing with the worship team. She was a few years younger than me, so when I went to college at UW-La Crosse we lost contact for a while. Katie got into UWL about the time I graduated. I tried to contact her, support her, set up a lunch date or two, but she would always reply with short answers and back out of plans we made. It wasn't like her. Something felt off.

The next time I saw Katie was at her funeral. I didn't find out until after the service that it was suicide. No one in the church would talk about it, but her brother confirmed my suspicion. She was seeing the pastor regularly for counseling, but it didn't help. I have no insight into Katie's sexual orientation. That may not have been relevant to her struggles. What I do know is that our pastor was NOT qualified to be her therapist. Perhaps if Katie has gone to a certified cognitive behavior therapist, she could have gotten help. She could have had more than two decades to live. But instead, everyone kept telling her that she just needed to pray harder. She wasn't getting better because her faith wasn't strong enough. All she had to do was rely more on God and less on herself.

What does this have to do with conversion therapy? Pastors are NOT qualified to council people on gender identity or sexual orientation just as they are NOT qualified to council someone who is clinically depressed. By passing this city ordinance, Mr. Mayor, you could very well be saving lives. "Let parents parent," one protestor's sign says. "Let pastors counsel on Biblical beliefs," says another. Well I say Katie's parents and our pastor are accomplices to manslaughter because they refused her the help she needed. *Shame on them*. Katie was a child of God and her life mattered. It could have been a beautiful one. The protestors outside your windows are asking no more than to let people control other people. They may believe they are doing the right thing by protesting, but my experience and my faith tell me otherwise.

I could have ended up like Katie. My mental health plummeted in 2018. I was on the verge of considering suicide as a viable option. But I didn't let Christian dogma stop me from getting the help I needed. I'm on anti-anxiety medication, which works great. I'm seeing a therapist which is helping me heal. I am closer to Jesus now than I ever was under the heavy weight of severe depression. Had I relied solely on my pastor to pastor me, I probably wouldn't be here writing this letter.

Please, and again I say PLEASE pass this ban. It will bring our community one step closer to breaking the dogmatic stigma against people getting help by the experts that ARE trained and qualified to help them.
