Subject: CUP approved for Combination "Class B" alcohol application - Householder Taverns LLC

This communication is to notify you that the permission for Householder Taverns LLC to apply for a Combination "Class B" alcohol license at 4329 Mormon Coulee Road was approved by the Common Council on July 14, 2022.

Be advised that applications must be submitted within 60 days or the permission becomes null and void for the remainder of the license year.

Please read the <u>Alcohol Beverage Submittal Requirements and Information</u> sheet - **IMPORTANT** information for both pre- and post-application filing.

- 1. Applicant (Householder Tavern LLC) completes the Original <u>Application for Alcohol Beverage</u>. List all members/directors/agent and answer all questions completely and legibly. Only one member needs to sign (notary not required).
- 2. Each member of the LLC and the agent (and any directors) must complete an Auxiliary Form.
- 3. Complete Schedule of Agent. There are residency requirements for the agent: must live in the State of Wisconsin for 90 days and within 25 miles of the City limits. The agent will need to complete the Responsible Beverage Server Course or have done so within the last two years and we need a copy of the completion certificate (or is agent on another license in Wisconsin). Here is a link to the approved beverage server courses through Department of Revenue: https://www.revenue.wi.gov/Pages/Training/alcSellerServer.aspx.
- **4.** If you plan to have live music, you will also need an Indoor Cabaret. The fee is \$135.
- 5. If you plan to sell cigarettes/tobacco products, you will need a Cigarette/Tobacco license. The fee is \$100.
- 6. With the application and all other documents, we need:
 - a. Corporate paperwork Articles of Incorporation (photocopy)
 - b. Wisconsin Seller Permit Number (photocopy)
 - c. Federal Employer Identification Number (photocopy)
 - d. Lease (photocopy)
 - e. Fee: \$320 (\$300 for alcohol and \$20 publication). If indoor cabaret, additional \$135. If cigarette/tobacco, additional \$100.00.

Note: We will soon be out of regular licenses and the additional \$10,000 may be required if we only have reserve licenses available.

There are two deadlines in the next 60 day required filing period.

- Wednesday, July 27 for a license in August (August 12, 2022 through June 30, 2023)
- Wednesday, August 31 for a license in September (September 16 through June 30, 2023)
 Note: The establishment must be open and operating and actively selling alcohol within 90 days of the license being granted.

When you are ready to file, you can do so in person during public service hours which are Monday – Thursday 8:00 a.m. to 4:00 p.m. in the lobby of City Hall – City Clerk is window 5.
