(X) ABATEMENT OF REFUSE OR

(c) Event or Gathering. "Event or gathering" means any group of three or more persons who have assembled or gathered together for a social

(d) Host or Allow. "Host" or "allow" means to aid, conduct, entertain, organize, supervise, control or permit a

gathering or event.

(e) Parent. "Parent" means any person having legal custody of a juve-


