AN ORDINANCE to amend Subsection 7.01 (I)(2) of the Code of Ordinances of the City of La Crosse to streamline administration of Orders to Correct for Storage of Personalty.

THE COMMON COUNCIL of the City of La Crosse do ordain as follows:

SECTION I: Subsection 7.01 (I)(2) is hereby amended to read as follows:

(I) STORAGE OF PERSONALTY.

(2) Abatement By Owner.

The owner, owners, tenants, lessess, and/or occupants of any lot within the City upon which such storage is made, and also the owner, owners, and/or lessees of said personalty involved in such storage (all of whom will hereinafter be referred to collectively as owners), shall jointly and severally abate said nuisance by the prompt removal of said personalty to completely enclosed buildings authorized to be used for such storage purposes, or otherwise to remove it to a location without the corporate limits of the City and it shall be unlawful if said owners allow said nuisance to exist or fail to abate said nuisance. If said operson responsible for abatement of nuisance does not abate the same within five (5) days as provided in (1), the Planning & Development Department, Division of Building and Inspections. Board of Public Works may cause said nuisance to be abated after providing fourteen (14) days notice with the cost of the same to be charged or assessed as a special charge under 66.0627 66.60(16), Wis. Stats.
