(2) In groups or crowds. No per-son shall loiter in a group or a crowd upon the public streets or sidewalks or in adjacent doorways or en-trances, or on street crossings or trances, or on street crossings or bridges or in any other public place or on any private premises without invitation from the owner or occu-pant, after being requested to move on by any police officer or by any person in authority at such places. (3) In places of public assembly or use. No person shall foliter in or about any depot, theater, dance hall, restaurant, store, sidewalk, parking lot, or other place of assembly or

lot, or other place of assembly or public use after being requested to move on by any police officer or by the owner or other person in charge of such place. Upon being re-quested to move, a person shall comply immediately with such request by leaving the premises or the area

(4)(2)When signs posted. No per-son shall loiter on private property posted by means of a sign or signs prohibiting such conduct after being requested to leave by the owner,
