Dear Steve,

Thank you for the opportunity to present our proposal for the Architectural Services for the Programming and Schematic Design phases to develop Trane Park. We have enjoyed our preliminary discussion about how you and the City would like to develop the park for children of all abilities. I am fully aware of your expectations and will work hard to meet and exceed them over the course of the project. The services we propose are as outlined below:

# **SCOPE OF SERVICES**

Our proposal includes the following services:

- A. Provide meeting time with the City of La Crosse and user groups to determine the project's program and overall needs.
- B. Work with the playground suppliers and designers to develop the concept drawing for the overall design.
- C. Provide Schematic Design drawings that reflect the final design solution. The Schematic Design package will include the following:
  - Overall site plan
  - Building plans and elevations
  - Playground equipment layouts
  - 3D image of the new park
- D. Provide a project budget and a breakdown of cost.
- E. Provide a project schedule from the start of Design Development through the completion of construction.
- F. Provide meeting and review time during the course of the design process. One trip will be provided to meet with the playground designers at their location.

### **TEAM**

Michael Swinghamer will lead the overall development of your project as Project Principal and will be your point of contact throughout the process. Clint Rasmussen will be the Project Coordinator and designer. Our

firm is strictly architectural, and is not planning to use outside consultants for the beginning Schematic Design phase. As the project develops in to the Design Development phase, additional consultants will be required.

#### **ASSUMPTIONS**

In presenting this proposal, we made the following assumptions:

- A. The design work will be done this fall and early winter. If the project continues through the Construction Documents phase it will be bid in Spring 2016 and constructed the following summer.
- B. The Parks and Recreation Department will take the lead in obtaining council and city approvals.
- C. The City of La Crosse will be contracted with the playground designers directly and River Architects will work with them to coordinate the design efforts.
- D. The project budget will be determined at the end of the Schematic Design phase.

#### **BASIS OF COMPENSATION**

We are proposing to complete the design services on an hourly rate basis not to exceed:

## **PAYMENT PROVISIONS**
