THE COMMON COUNCIL of the City of La Crosse does ordain as fol-

lows:
SECTION I: Section 10-756 is hereby amended to add a definition as follows:

Sec. 10-756. - Definitions. Charitable purpose means a benevolent, educational, philanthropic, humane, scientific, patriotic, social welfare, advocacy, public health, environmental conservation, civic or

vironmental conservation, civic or other eleemosynary objective. SECTION II: Section 10-757(10) is hereby amended to read as follows: Sec. 10-757. Exemptions. (10) Any charitable organization established for a charitable purpose and registered under Wis. Stat. § 440.42 with the State of Wisconsin; provided that there is submitted to the City Clerk proof that such charitable organization is registered. All persons exempt under this subsection shall be required to comply with tion shall be required to comply with the applicable regulations. Any char-itable organization not registered under Wis. Stat. § 440.42 with the State of Wisconsin shall be required to obtain a license under this sec-tion.; provided, however, all persons

exempt under this subsection shall be required to comply with applicable regulations; SECTION III: Should any portion of

this ordinance be declared uncon-stitutional or invalid by a court of competent jurisdiction, the remain-der of the article shall not be af-
