ORDINANCE NO. 4964  
A SECOND AMENDED  
ORDINANCE to amend the  
definition of "Junk Dealer" in  
Section 10-457 and to create  
Section 104-463(h) of the Code of  
Ordinances of the City of La Crosse  
regarding itinerant junk dealers.

THE COMMON COUNCIL of  
the City of La Crosse do ordain as  
follows:

SECTION I: The definition of  
"Junk Dealer" in Section 10-457  
is hereby amended to read as  
follows:

Junk dealer means a person  
who operates a junkyard or a  
person who operates as an  
itinerant junk dealer, as defined in  
this section, within the City.

SECTION II: Section 10-463(h)  
is hereby created to read as  
follows:

(h) No vehicle registered within  
the City of La Crosse as  
required under Section 10-  
483(5) may be stopped, left  
unattended or parked on  
any public right of way within  
1,000 feet from land zoned for  
single family residence  
district, residence district,  
multiple dwelling district,  
special multiple dwelling  
district or low density multiple  
dwelling district unless the  
operator is actively engaged  
in the course of business  
at the time the vehicle is  
parked.

SECTION III: Section 10-  
483(5) is hereby created to read  
as follows:

(5) A description of each vehicle  
by factory number, year, make,  
model and license plate number  
of any vehicle to be used by the  
applicant in the conduct of the  
applicant's business.

SECTION IV: Should any  
portion of this ordinance be  
declared unconstitutional or invalid  
by a court of competent jurisdiction,  
the remainder of the article shall  
not be affected.

SECTION V: This ordinance  
shall take effect upon passage and  
publication subject.
