This section 22ndday of April 2017 does not apply to agricultural zoned districts of the City and animals per-mitted in connection with lawful uses and thereafter on the following dates, to wit: therein or wild animals as permitted in section 6-9. This section shall fur-ther not apply to licensed lofts for the keeping of homing, sporting or show pigeons that were established lofts existing prior to January 1, 2005, and maintain a license for such loft or lofts under section 6-15. This section does not apply to the keeping of chickens as provided in section 6-16. (b) The following animals shall be prohibited except as provided by their respective sections: therein or wild animals as permitted being at least once in each week for 1 their respective sections: successive week(s).
