Resolution appropriating and reallocating funds for an Accelerated Transportation Infrastructure Maintenance and Reconstruction Program.

## AMENDED RESOLUTION

WHEREAS, the City of La Crosse's transportation infrastructure includes 223 miles of streets, over 40 miles of on-street and off-street bicycle facilities, sidewalks and a fixed-route transit system that offers both general public and specialized transportation; and

WHEREAS, the City of La Crosse currently reconstructs and maintains about three (3) to four (4) miles of streets annually and intends to create an accelerated transportation infrastructure reconstruction and maintenance program to reconstruct and maintain an additional five (5) to seven (7) miles of street per year, implement the capital investment recommendations from the 2012 Bicycle and Pedestrian Master Plan and implement the transit enhancement recommendations from the Grand River Transit Service Enhancement & Policy Plan 2015-2025.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of La Crosse that it hereby supports the creation of an accelerated transportation infrastructure reconstruction and maintenance program including additional street reconstruction and maintenance, bicycle and pedestrian capital investments and transit enhancements.

BE IT FURTHER RESOLVED that it hereby authorizes the reallocation and appropriation of the following funds for use in the accelerated transportation infrastructure reconstruction and maintenance program as follows:
