SECTION I: Section 115-347(8) is SECTION I: Section 115-347(8) is hereby created to read as follows: (8) Distilleries for the production and bottling of distilled beverages, which includes a tasting room, with an annual production of less than 1,000 barrels per year and no larger than 5,000 square feet shall be a conditional use in the local Busia conditional use in the Local Busi-ness, Community Business and Commercial Districts. The storage of all items or materials utilized for the production of distilled beverages shall be in enclosed buildings unless otherwise approved by the Common Council. Distilleries must meet all applicable requirements associated with any state and federal licenses. Review of these applica-tions shall include, but not be limited to, the following; location of prop-erty, current use of property, building type, construction type and ad-herence to National Fire Protection Association and International Build-

Association and international Build ing Code requirements. SECTION II: Should any portion of this ordinance be declared uncon-stitutional or invalid by a court of competent jurisdiction, the remain-der of this division shall not be affected.
