lows: SECTION I: Sec. 115 - 1 is hereby amended to include the following: Health club means a building or

portion of a building designed and equipped for the conduct of sports, exercise, leisure activities or other customary and usual recreational activities for the purpose of physical

SECTION II: Sec. 115-347(6)c, is hereby amended as follows: c. After meeting the prerequi-sites above, a conditional use permit application may be submitted for a property located in any residential zoning district for the following uses: (Drive-ins or drive-through facilities are prohibited for any use.)

1. The following uses may be considered for use in a residential considered for use in a residential zoning district neighborhood and because of their nature require no off-street parking: (If the following uses are proposed to have three or more employees at one time then a 500-foot notification is required and off-street parking shall be provided.)

(i) Ice cream and candy/confectionery store.
(ii) Non-adult-oriented used book-

(iii) Barber shops and beauty par-

(iv) Pet grooming establishment. (v) Photography studio. (vi) Butcher shop.

(vii) Bakery. (viii) Bike/skate shop. (ix) Artisan shop.

Repairing/alterations

(x) Repairing/alterations of clothing apparel shop.

2. The following uses may be considered for use in a residential zoning district neighborhood and because of their nature require ade-quate off-street parking and also re-quire a notification radius of 500
