Thanks for the message. No problem starting with me.

This issue needs to go to the Board of Public Works. Any use of City outlets or electricity needs to be approved by the Board of Public Works. We send all these types of requests to them, such as for the farmer's markets or block parties.

We need to determine if this electrical service has a meter or is an older, unmetered service. By State Statute, any electric use would need to be estimated and billed to the user by Xcel Energy. The BPW has the authority and can decide whether it is OK with giving away electricity.

I'm not sure who to contact about this, so I'm starting with you. We have had several complaints about people charging their electric vehicles near Cameron Park, 400 block of King St. I was wondering if there is any way we can either install signage at this location denoting the area as a "charging station", or if we can actually erect an "Electric Vehicle Charging Station" at this location (and other locations throughout the city) and charge a small fee for its use? From what I understand, the cost of charging an electric vehicle is only a few cents, much like an engine block heater.

As far as I know, there is no Ordinance prohibiting the use of those outlets, so there is no enforcement action to be taken.

I've talked to several people about this idea, and they feel it is a great way to promote cleaner alternatives for residents and visitors of La Crosse.

Let me know your thoughts, or somebody else who may be a more appropriate contact for me.
