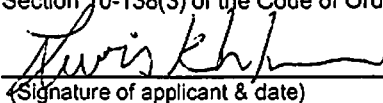

Note: The certificate of insurance must described the event and the additional insured endorsement must accompany the certificate.

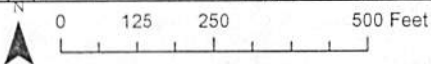

Dear Board Members,

The City Planning and Development Department, along with a coalition of groups that include the Wisconsin Bicycle Federation, La Crosse Area Visitors and Convention Bureau, and Downtown Main Street, Inc., requests permission from the Board of Public Works to allow the following:

1. Closure of King St. from 4th St. to 5th Ave., 5th Ave. from King St. to Main St., Jay Street from 5th Ave. to the eastern alley, and Main St. from 5th Ave. to 9th St. (as depicted in the attached map) on Sunday, September 3, 2017 from 9:00AM to 6:00PM for an open street event to promote walking, bicycling, and other activities in the street.
2. Rerouting bus routes 4 and 5 around the open street during the event
3. Signs and banner related to the event within the closed area during the event
4. Property owners along the route may use the public sidewalks and parking spaces adjacent to their respective businesses during the event for activities and displays.
5. Artists, performers, and food vendors may use the public sidewalks and parking spaces for performances, displays and demonstrations under the direction of Open Streets La Crosse.
6. Non-permanent chalk art on sidewalks, in crosswalks, and potentially a non-permanent mural in one intersection.
7. Placement of tables, chairs, and tents within the street during the event.
8. Special Event Cabaret licenses will be applied for through the City Clerk, upon approval.

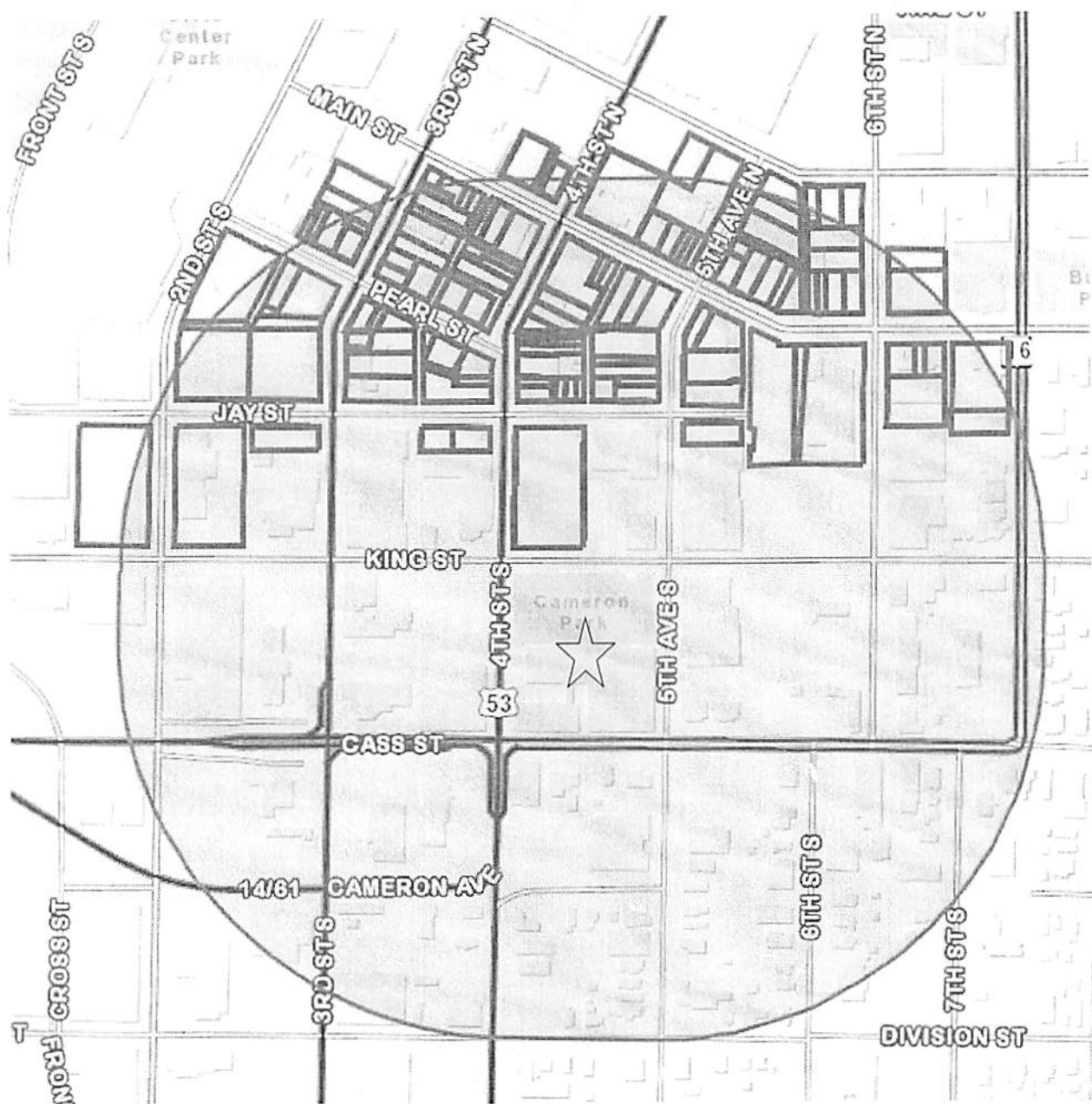
