ORIG PLAT NORTH LA CROSSE LOT 14 BLOCK 28 EX W 71FT & EX E 8FT TAKEN FOR ALLEY IN V832 P925.
SECTION II: The property is rezoned with the condition that the context sensitive design issues be referred to the Design Review Committee and the prohibition on employment growth above 12 employees be recorded to alert the current owner-operator and potential successors of this sitie/zoning limitation. SECTION III: Should any portion of this ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of this division shall not be affected.
SECTION IV: This ordinance shall take effect and be in force from and after its passage and publication.
