## **AGREEMENT RIDER-1**

**This is a Rider to the Agreement entered into by and between Community Link, Inc., Abby Vans and City of La Crosse dated January 1, 2017 (hereinafter the "Agreement"). Community Link, Inc. hereby grants the following addition/modification to the Agreement:**

**The following language is hereby an ADDITION to the Agreement:**

The service hours for MTU Mobility Plus Paratransit Client List A for the City of Onalaska during Route 9 Onalaska service are as follows, Monday through Friday 6:55am-10:23am and 1:25pm-6:23pm. There is no weekend service. The exception for this would be wherever there is fixed route service for the Route 5 Valley View Mall bus in Onalaska. As long as the drop off is located on the route of 5 Valley View Mall bus, the hours would be the same as the City of La Crosse. Monday-Friday 5:10am-10:40pm, Saturday 7:40am-7:40pm and Sunday 7:40am-6:40pm. For example Gundersen Dialysis, Gundersen Clinic Onalaska, Target, Shopko, TJ MAXX and etc...

Complimentary Paratransit is only provided when there is fixed route service. There is no complimentary paratransit service for Client List A in La Crescent or French Island because there is fixed route demand response for these areas.

**In the event a discrepancy should arise between the provisions of this Rider and those of the Agreements, the provisions of this Rider shall apply.  
The terms of the Agreement not modified by this Rider shall remain in full force and effect.**

**This Rider, together with the above referenced Agreement, constitutes the entire agreement of the parties and supersedes all prior understanding, whether written or oral. The contents of this Rider remain in full force and effect as long as the signed Agreement is in full force and effect.**
