RE: CITY OF LA CROSSE HUMAN RIGHTS COMMISSION COMPLAINT OF GENEAN THOMAS

Dear Ms. Lehrke:

My law firm represents the Housing Authority of the City of La Crosse in matters related to the complaint filed by Genean Thomas on August 29, 2017. All correspondence in this matter should be sent to my attention.

The purpose of my letter today is to ask the Human Rights Commission to toll the time for the Housing Authority to respond to this complaint until such time as the complainant has furnished the Housing Authority with an authorization for release of information. Failure to provide an authorization for release of information limits the Housing Authority's ability to respond, as well as participate in a mediation or hearing.

This issue was previously discussed with the City's attorney, Paul Fredrickson, but may not have been conveyed by him directly to the Commission. The Housing Authority is funded by the U.S. Department of Housing and Urban Development ("HUD") and is subject to federal law and HUD administrative rules. Federal law and HUD regulations prohibit the Housing Authority from unauthorized disclosure of tenant personally identifiable information. These laws include: Section 6 of the Housing Act of 1937, the Privacy Act of 1974, 5 U.S.C. § 552a (Privacy Act), The Freedom of Information Act (FOIA), 5 U.S.C. § 552, and Section 208 of The E-Government Act, The Housing and Community Development Act of 1987, 42 U.S.C. § 1437d (q)(4), 42 U.S.C. § 1437d (t)(2), 42 U.S.C. § 3543, the Stewart B. McKinney Homeless Assistance Act of 1988, 42 U.S.C. § 3544; 24 C.F.R Part 5, Subpart B, and 48 C.F.R. 24.104. It is our assessment that these laws supercede local ordinance. I am also attaching for your reference a copy of the Housing Authority's Confidentiality Policy, which comports with the above.

In light of this, the Housing Authority is asking that this commission toll the time for it to respond to Ms. Thomas's complaint. By copy of this letter, the Housing Authority is asking

All employees and members of the Authority are required to abide by this standard. Only inspectors, auditors, investigators, and others who are engaged in their normal functions as approved by the Department of Housing and Urban Development may have access to confidential information concerning residents and applicants.

AUTHORIZATION FOR RELEASE OF INFORMATION

(hereinafter "Authorization")

TO: Housing Authority of the City of La Crosse (hereinafter "PHA")

PHA is hereby authorized to discuss with, furnish, and release to the Human Rights Commission for the City of La Crosse or its authorized representatives any and all information obtained during Thomas' application for tenancy and continued tenancy with the PHA.

Thomas agrees to indemnify, protect, and hold harmless PHA from any an all claims related to PHA's release of information pursuant to this Authorization. Thomas understands and agrees that by granting this Authorization she is waiving certain privacy and confidentiality rights under federal, state, and local law, including but not limited to Section 6 of the Housing Act of 1937, the Privacy Act of 1974, 5 U.S.C. § 552a (Privacy Act), The Freedom of Information Act (FOIA), 5 U.S.C. § 552, and Section 208 of The E-Government Act, The Housing and Community Development Act of 1987, 42 U.S.C. § 1437d (q)(4), 42 U.S.C. § 1437d (t)(2), 42 U.S.C. § 3543, and the Stewart B. McKinney Homeless Assistance Act of 1988, 42 U.S.C. § 3544. Thomas waives notice of any disclosures made pursuant to this Authorization. The terms of this paragraph shall survive the expiration of this Authorization.

This Authorization shall remain in effect for the longer of (1) one year from the date of signing, or (2) the date all proceedings arising from Thomas' complaint filed with the Human Rights Commission for the City of La Crosse on August 31, 2017, are either fully and finally adjudicated or dismissed with prejudice.

A copy of this Authorization shall be deemed as effective as the original.
