SECTION I: Section 2-422 is hereby amended to read as follows: Sec. 2-422 - Residency requirements, boards, commissions,

(a) Except as otherwise provided herein, no person shall be appointed or elected to a City board, commission, commistion or governing body unless such person is a resident of the City of La Crosse. Any such person so appointed or elected shall cease being a member of such board, commission, committee or governing body when such person is no longer a City resident.

(b) Except as otherwise provided

herein, in no event shall nonresidents of the City of La Crosse constitute:

(1) Constitute Mmore than one-third of the members of any such board, commission, committee or

governing body; or
(2) 50 percent or more of the quorum Serve as the chair or president of any board, commission,

committee or governing body.

(c) Subsection (a) and (b) of this section shall not apply to the following boards, commissions, committees and governing bodies:

(1) La Crosse Transit Utility Board in accordance with division 5 of this atticle.

(2) International Committee in accordance with division 9 of this article.

(3) Those boards, commissions, committees and governing bodies that permit non-City residents by Federal or State law; or by Common Council Resolution for an ad hoc committee which permits non-City residents due to their business or community affiliation.
