Motion 3: Made by Phil Addis and seconded by Amanda Jackson.....Subject to mutual agreement between the La Crosse Center Board, the La Crosse Park Board and the La Crosse City Council all expenses related to the Park upgrades underneath and adjacent to the overhang will be covered by the La Crosse Center project costs. Passed unanimously.
