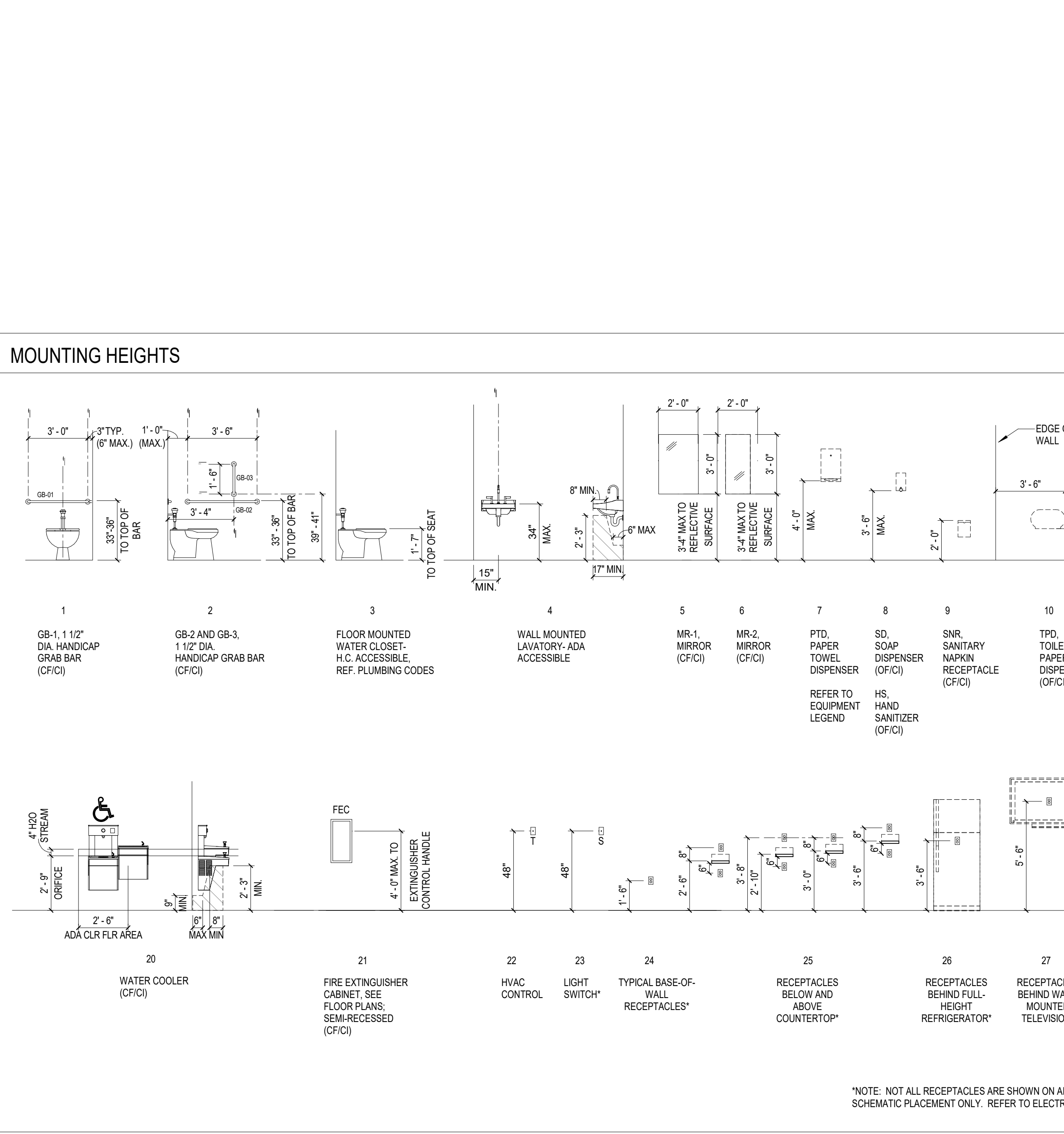

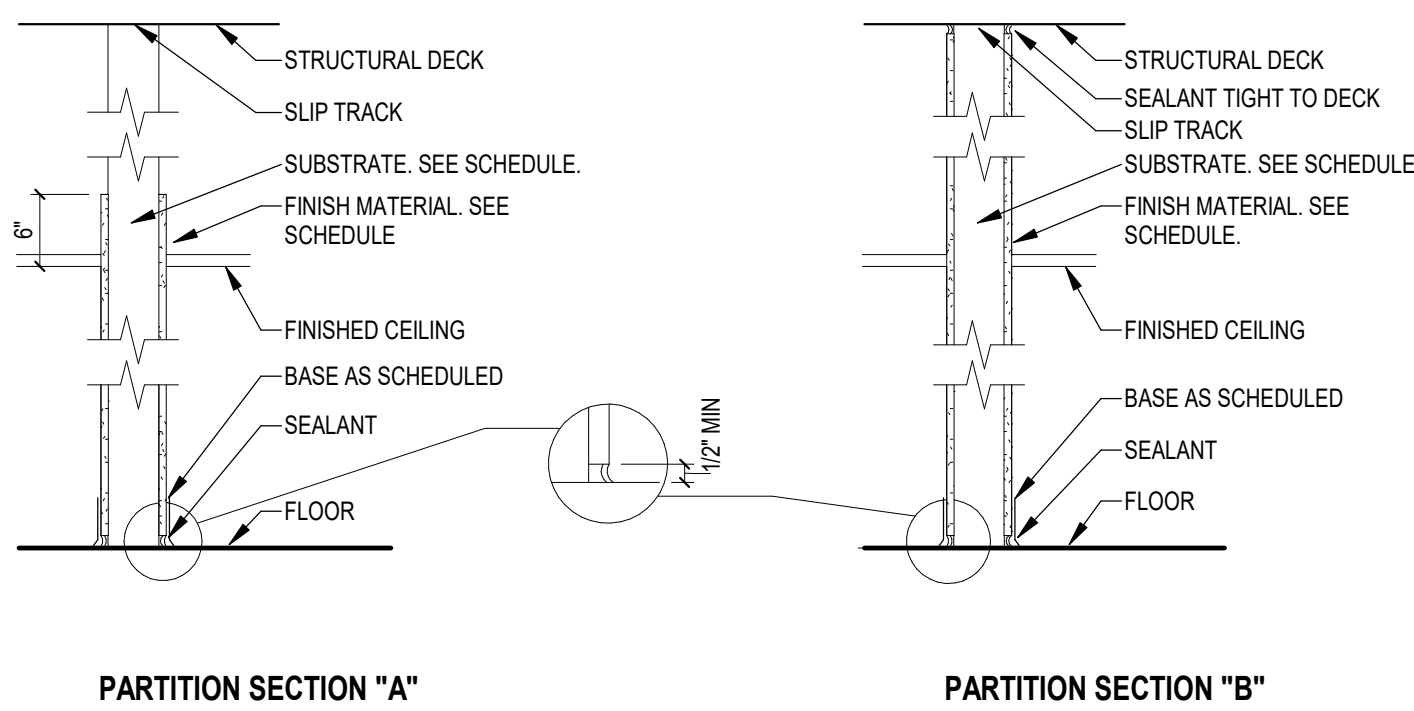
GENERAL NOTES

- CONTRACTOR IS TO REFER TO FLOOR PLANS FOR PARTITION LOCATIONS.
- USE CEMENTITIOUS BOARD AT FINISH SIDE OF WET WALLS, TYPICAL. WET WALLS ARE WALLS IN SHOWERS AND WALLS WITH SINKS, TOILETS, AND URINALS THAT ARE TO RECEIVE TILE. WRAP CEMENTITIOUS BOARD ON WALLS PERPENDICULAR TO THE WET WALLS IF THE WALL IS CLOSER THAN 3'-0" TO THE WATER SOURCE FOR A MINIMUM LENGTH OF 5'-0".
- USE GLASS-MAT INTERIOR GYP BD AT ALL OTHER TILE LOCATIONS (NON-WET WALLS).
- AT THE INTERSECTION OF PARTITIONS OF DISSIMILAR RATINGS, THE PARTITION OF THE HIGHER RATING SHALL CONTINUE THROUGH UNINTERRUPTED AND SHALL TAKE PRECEDENCE OVER THE LOWER PARTITION RATING.
- REFER TO LIFE SAFETY PLANS FOR SMOKE TIGHT AND FIRE RATED WALLS.
- FOR HEALTH CARE OCCUPANCIES, CALCUL ALL PENETRATIONS.
- SEE DRAWINGS FOR SPECIFIC PARTITION DETAILS.
- PROVIDE ACOUSTICAL JOINT SEALANTS AT ALL PENETRATIONS IN WALLS WITH PARTITION SECTION "B".
- STC RATING IS A DESIGN GUIDE AND SHOULD BE VERIFIED PER DESIGN REQUIREMENTS.

1. DEMOLITION KEYNOTES ARE NOT SHEET-SPECIFIC AND MAY NOT APPLY TO ITEMS ON THIS SHEET.
2. DASHED LINES INDICATE DEMOLITION AREAS FOR ARCHITECTURAL COMPONENTS INCLUDING BUT NOT LIMITED TO WALLS, STUDS, DOORS, DOOR FRAMES, CABINETS, COUNTERS, ETC. CEILING, GRID AND FLE SHOULD BE COMPLETELY DEMOLISHED IN PROJECT AREA UNLESS OTHERWISE NOTED. EXISTING FLOOR FINISH SHOULD BE COMPLETELY REMOVED IN PROJECT AREA UNLESS OTHERWISE NOTED.
3. ALL ITEMS REQUIRING DEMOLITION ARE NOT NECESSARILY SHOWN ON THE ARCHITECTURAL DRAWINGS. CONTRACTOR SHALL COORDINATE THE DEMOLITION OF MECHANICAL SYSTEMS, PLUMBING, ELECTRICAL, SECURITY, AUDIOVISUAL, AND FIRE ALARM SYSTEMS IN CONJUNCTION WITH THESE PLANS. SEE MEP DRAWINGS FOR ADDITIONAL DEMOLITION INFORMATION.
4. SEE CIVIL AND LANDSCAPE DRAWINGS FOR SITE DEMOLITION WORK.
5. COORDINATE WITH OWNER TO DETERMINE WHICH DEMOLITION ITEMS OR EQUIPMENT ARE TO BE SALVAGED AND RETURNED TO THE OWNER. CATALOG AND STORE MATERIALS AT OWNER'S REQUEST AND DIRECTION.
6. ALTHOUGH SPECIFIC PIECES OF EQUIPMENT OR MISCELLANEOUS CONSTRUCTION MAY NOT BE INDIVIDUALLY KEYNOTED, DEMOLITION PLANS IMPLY THAT THE ENTIRE SYSTEM OR ASSEMBLY BE REMOVED TO ACCOMPLISH THE NEW WORK.
7. DEMOLITION OF WALLS INCLUDES ALL ATTACHED FIXTURES AND EQUIPMENT.
8. PATCH FLOOR AND PROVIDE SELF-LEVELING COMPOUND FOR UNEVEN AREAS.
9. IN AREAS AFFECTED BY DEMOLITION WORK, PATCH AND REPAIR FLOORS, CEILING AND WALLS SCHEDULED TO REMAIN TO A "PRECONSTRUCTION" QUALITY.
10. AT WALLS SHOWN TO REMAIN, BUT RECEIVING NEW FINISHES, REMOVE EXISTING FINISHES, INCLUDING WALL COVERING, AND PREPARE WALL TO RECEIVE NEW FINISHES.
11. CAP ALL ABANDONED PLUMBING AND WASTE PIPING BEHIND/BELOW NEW FINISHES, TYPICAL. SEE ALSO PLUMBING DRAWINGS.
12. WHERE A DOOR OR WINDOW IS SHOWN WITHIN A WALL THAT IS SHOWN TO BE DEMOLISHED, THE DOOR, WINDOW AND FRAME WITHIN THE WALL SHALL ALSO BE DEMOLISHED, UNLESS NOTED OTHERWISE.
