RESOLUTION

WHEREAS, the Youth Enrichment Association of La Crosse, Inc. (YEA) is currently an independent 501(c)(3) corporation which provides support and funding for recreation activities for the City of La Crosse, and

WHEREAS, YEA desires to dissolve its corporation and discontinue its 501(c)(3) status and to operate as a program of the City of La Crosse Parks & Recreation Department, and

WHEREAS, it would be beneficial to the City of La Crosse for YEA to operate as a program of the City of La Crosse Park & Recreation Department.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of La Crosse that upon dissolution of YEA as a corporation and discontinuation of its 501(c)(3) status, YEA shall be designated as a program of the City of La Crosse Park & Recreation Department.

BE IT FURTHER RESOLVED that there is hereby established an interestbearing trust account and a checking account in the name of Youth Enrichment Association for the purpose of revenue and expenditures for and on behalf of YEA.

BE IT FURTHER RESOLVED that the appropriate City officials, the Director of Parks & Recreation, the Recreational Superintendent, the Youth Recreation Supervisor and the Recreation Supervisor are hereby authorized to be signatories on the above-referenced accounts.

BE IT FURTHER RESOLVED that the Director of Parks & Recreation, Finance Director and City Attorney are authorized to take any and all steps necessary to effectuate this resolution.
