The event will wrap up by 3:30 and cleanup of the atrium/grounds will be completed by 5:00 p.m.

**The Event:** Enchanted Forest is a non-scary, trick-or-treat hike for families. Volunteers dress up as fairytale creatures and hand out candy to participating children. The event also includes live music by a children's musician, magic performance, a petting farm, and other forms of family entertainment. Popcorn and hot chocolate is also available to participants at the end of the trick or treat course at no charge.
