## RESOLUTION

WHEREAS proposals for investment services for the period of April 1, 2019 through March 31, 2020 were received on February 28<sup>th</sup>, 2019.

NOW THEREFORE BE IT RESOLVED by the Common Council of the City of La Crosse that it hereby approves the following bids for said investment services:

- 1.) River Bank for the \$9,000,000 level of investment at the rate of .00.21 per month in excess of the monthly rate established by the State of Wisconsin Local Government Investment Pool (LGIP) including collateralization, and
- Coulee Bank for the \$7,000,000 level of investment at the rate of .00.26 per month in excess of the monthly rate established by the State of Wisconsin Local Government Investment Pool (LGIP) including collateralization, and
- State Bank Financial for the \$10,000,000 level of investment at the rate of .0022 per month in excess of the monthly rate established by the State of Wisconsin Local Government Investment Pool (LGIP) including collateralization,

all in accordance with the report of bids and recommendations of the Director of Finance/Treasurer, and

BE IT FURTHER RESOLVED that the Mayor and City Clerk are authorized to sign said Investment Services agreements on behalf of the City.

BE IT FURTHER RESOLVED that the Director of Finance/Human Resources is hereby authorized to take any and all steps necessary to effectuate this resolution.
