



## Q&A regarding the La Crosse Center Facilities Conditions Assessment created by ISG on July 10, 2017

#### What is a Facility Conditions Assessment?

A Facility Conditions Assessment is a report that focuses on the physical existing conditions of a building. It confirms the current state of the building and identifies issues that should be considered for maintenance, replacement, or other treatment. Engineers, architects, and technicians research plans, review maintenance records, and perform on-site inspections. They evaluate areas including, but not limited to: the site, the building exterior and interior, interior finishes, hazardous materials, accessibility, plumbing systems, mechanical systems, technology systems, electrical systems, elevators, and escalators.

The Facility Conditions Assessment is comprehensive and serves as a full, exhaustive audit of the facility. Not all items identified in a Facility Conditions Assessment require immediate maintenance, replacement, or treatment. It covers "nice to have" cosmetic updates and modernizations as well as "must have" repairs or replacements. Some items may call for immediate attention, while others may merely need to be addressed some day in the future.

#### What is deferred maintenance?

Deferred maintenance refers to maintenance, system upgrades, or repairs that are necessary but deferred to a future budget cycle or postponed until funding becomes available. Deferred maintenance is implemented in order to save costs, meet budget funding levels, or realign available budget monies and priorities. Though backed by inspections and data, the decision to defer an upgrade or repair is made through a subjective process of balancing present and future priorities.

Think about this as you would when considering repairs for your home. If you have an aging roof, a broken refrigerator, and a cracked driveway; rather than replace all immediately, you will prioritize and spread the costs out over time.

## Why have cost estimates for building maintenance, upgrades, and repairs varied?

After the completion of the Facility Conditions Assessment report in July of 2017, the La Crosse Center Board and staff reviewed it to begin determining priorities, and the construction manager began estimating costs to address each item in the report. The initial cost estimate for all items in the report was approximately \$30MM.

This was NOT an estimated cost of all deferred maintenance. Many of the items in the Facility Conditions Assessment were potential upgrades or options for updating to like-new condition.

Actual deferred maintenance needs, after prioritization, were determined to be approximately \$13MM. Then, with the decision to rebuild rather than renovate the North Hall, approximately \$3MM in deferred maintenance was saved, reducing the total deferred maintenance need to approximately \$10MM.

It is an industry best practice to remediate deferred maintenance in phases so that maintenance is consistent and ongoing. With that in mind, the Board chose to allocate \$6.7MM of the available project funds to deferred maintenance in 2020-2021.

Additional deferred maintenance funding is anticipated through the partnership of The City of La Crosse and Johnson Controls.

## Are all items from the Facility Conditions Assessment being addressed?

Yes. All items referenced in the Facility Conditions Assessment are being addressed in one way or another. The La Crosse Center Board and staff used the report to set priorities for now and the future. Some items will be added, some will be replaced, some will be upgraded, and some will be maintained.
