In an effort to address recurring sewer system backups to residents in the 29<sup>th</sup> and Fairchild neighborhood during heavy rainfall events the City of La Crosse is offering a program to provide up to \$2,000 to cover the installation of a backwater prevention system.

To qualify a residence must be included in the identified effected area (attached list) or submit a request for consideration to be added to the program area.

Three written estimates must be submitted. The property owner should obtain three written price estimates from three different licensed plumbing contractors for the supply and installation of a sewer backwater valve with covered access box and two cleanouts, one on each side of the backwater valve (see the Backwater Valve Assembly Detail attached). Under certain circumstances, less than three estimates may be accepted by program staff. If you are submitting less than the required three estimates, you must obtain prior approval from the utilities office in order to receive reimbursement.

Completed Backflow Prevention Program Agreement must be submitted. Complete and return the Backflow Prevention Program Agreement Form (attached). Program eligibility will not be authorized until the completed form is received at the utilities office address listed above.

Notice to proceed. Once the estimates and signed agreement have been received by the utilities office and reviewed, a notice to proceed will be given. The notice serves as your guarantee that funding has been set aside specifically for the installation of a backwater valve at the property.


Once the notice to proceed is received by the property owner with the approved dollar amount, the property owner may hire the appropriate licensed plumbing contractor for the installation of the backwater valve.

Plumbing permit must be issued. A plumbing permit will be required at an additional cost. The cost will be added to the existing permit and will follow the same guidelines for final inspection. Contact the Building Division at 608-789-7530 at least one day in advance to schedule a final inspection.

The plumbing contractor is to bill the City of La Crosse Sewer Utility directly at the utilities office for payment. However any charges over the approved amount will be the responsibility of the property owner.


