Section I: Section 42-47 is hereby amended to read as follows:

Sec. 42-47. Tax Imposed. Pursuant to Wis. Stat. § 66.0615, a tax is hereby imposed on the privilege and service of furnishing, at retail, rooms or lodging to transients by hotel keepers, motel operators and other persons furnishing accommodations that are available to the public, irrespective of whether membership is required for the use of the accommodations. Such tax shall be at the rate of eight eleven nine and one-half (9.5%) percent. Such tax shall not be subject to the selective sales tax imposed by Wis. Stat. § 77.52 (2) (a) 1, and is not to be imposed on the Selective sales tax imposed by the Selective sales tax imposed by Wis. Stat. § 77.52 (2) sales to the Federal government and persons listed under Wis. Stat.

and persons listed under Wis. Stat. § 77.54(9a).
SECTION II: This ordinance shall sunset in twenty (20) years from the date of effect and shall revert to the original eight (8%) percent.
SECTION III: Should any portion of this ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of the article shall not be remainder of the article shall not be

affected.
SECTION VI: This ordinance shall take effect upon passage and publication on October 1, 2019.
