**Fire Department Monthly Report**  
**August 1<sup>st</sup> through August 31<sup>st</sup>**

**In the News:**

- 8/4 The La Crosse Fire Department responded at 2:34am to reports of a porch fire at 1017 7<sup>th</sup> St S. Crews arrived to find smoke coming from the enclosed porch of a two-story, single-family home. A bystander had already used a dry chemical extinguisher to minimize the flames for the fire department's arrival. The damage was considered minor and all of the occupants were evacuated safely.
- 8/8 The La Crosse Fire Department has been re-accredited for another five years. La Crosse is one of 33 departments to be accredited and only one of two from Wisconsin.
- 8/8 The La Crosse Fire Department was dispatched to the mall about 1:50pm for a fire in the mulch outside the store. While the mulch fire was put out, the callers were concerned the fire may have spread from the mulch into the building. Fire crews arrived and found no visible smoke or fire outside; however, the strong smell of smoke led to the discovery of wisps of smoke coming from the window casement ledge inside the store.
- 8/8 Active shooter drills are becoming more common in workplaces and schools and La Crosse holds at least one per year. Due to the low frequency and high intensity of these situations, Fire, EMS and law enforcement practice these scenarios, in tandem, as often as we can. The La Crosse Fire Department can provide with assistance or information about training like Stop the Bleed or active shooter civilian response training.
- 8/9 Shortly before 7am, La Crosse Fire Department was called just a few feet away for a broken gas line. The apartment building, at which the line was located in front of, was evacuated as a safety precaution.
- 8/23 Firefighters were called to Shimmy's, a bar and restaurant on West Ave for a fire outside, near a window. The fire was caused by discarded smoking materials. Patrons were safely evacuated and no injuries were reported. The business was able to reopen later that same day.
- 8/25 The La Crosse Fire Department responded to an apartment building at 7:22am where there was heavy smoke and fire visible. Around 17 people were displaced by the fire, but there were no injuries reported. Investigation determined the fire was caused by an unattended candle.






