In the News

On September 16, we announced the early retirement of La Crosse Police K-9 Zaback. Zaback had been with the Department since 2013 and was assigned to Officer Trenton Bowe. Unfortunately, Zaback sustained injury to his back, affecting his control of his back legs, and was recommended for surgery. Based on the prognosis and limitations provided by the UW Madison veterinarian, it was decided that Zaback should retire and spend his retirement with his family.

On October 2nd, several officers participated in Coffee with a Cop – our 4th year of hosting this event. Officers were stationed at five coffee shops throughout the City and were able to connect with citizens. The event is a great way to forge relationships in a relaxed and fun setting. We look forward to expanding this by hosting a few events throughout the year at various businesses.

The La Crosse Police Department was recently notified that our Domestic Abuse Reduction Team (D.A.R.T.) was awarded a continuation grant in the amount of \$450,000! This grant, to be used over a 36-month period, will allow us to continue our important work with the victims of domestic abuse and violence against women. D.A.R.T. is a collaboration with several other entities including New Horizons Shelter and Outreach Centers; La Crosse County District Attorney's Office, Circuit Court Judges, Justice Support Services, and Family Court Services; and the Hmoob Cultural and Community Agency.

Detective Lieutenant Andrew Dittman recently attended Death Investigation School put on by the Wisconsin Department of Justice – Division of Criminal Investigation. Upon completion of the school, all attendees were given a test for certification purposes. Lt. Dittman received the 3rd highest score amongst all participants. Lt. 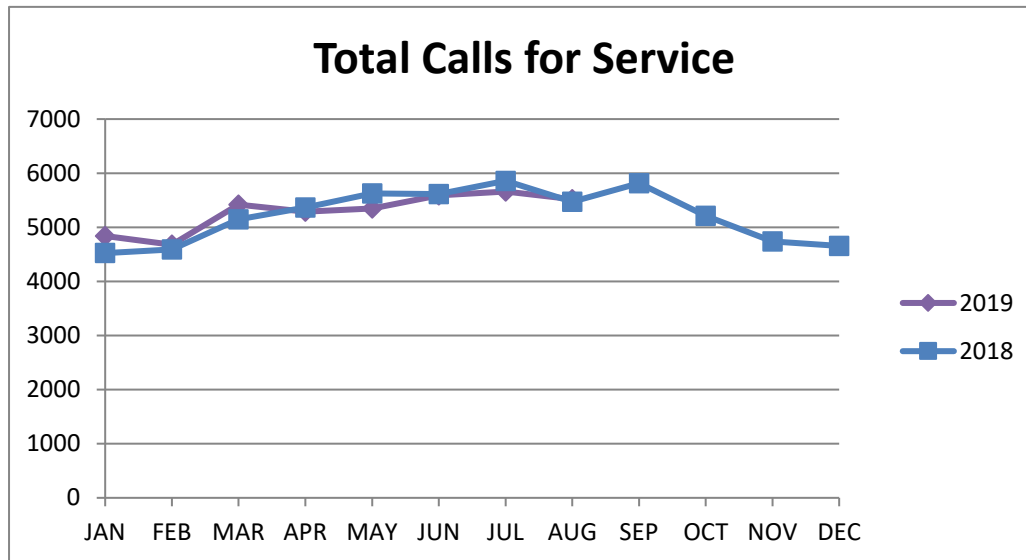

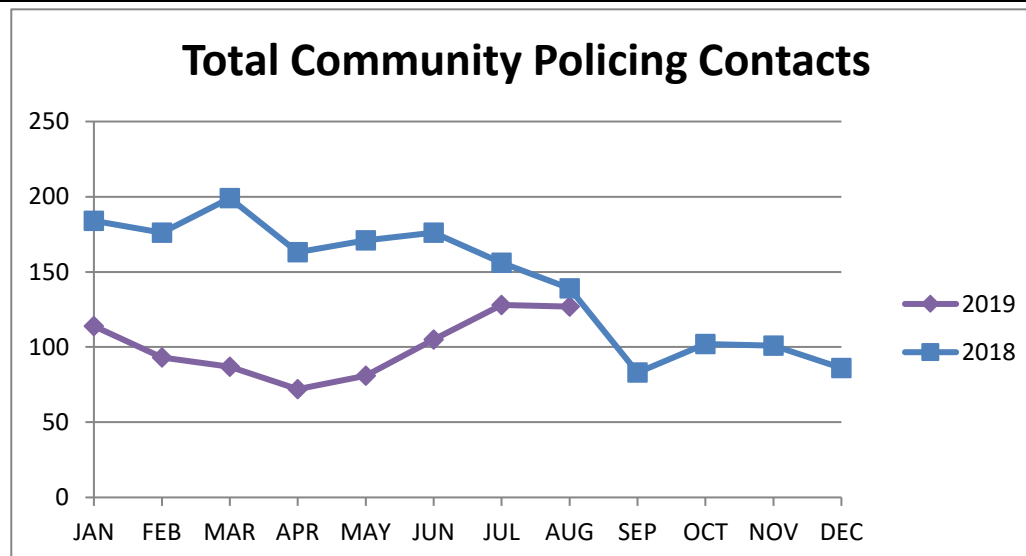
AUGUST 2019 YTD
