ORDINANCE No.: 5128.

AN ORDINANCE to amend Socion 2-604 of the Code of Ordinances of the City of La Crosso adding a member to the La Crosso Center Board. THE COMMON COUNCIL of the City of La Crosso do ordain as follows:

Section I: Section 2-604 is hereby amended to read as follows:

Sec. 2-604. Membership and organization.

The La Crosso Center Board shall consist of nine ten members who shall be qualified electors or residents of the City, except that if the Margapaper appoints a representative of the La Crosso County Convention and Visitors Bureau to the La Crosso Center Board, that appointee need not be a resident of the City of La Crosso. One member shall be a Council Member and one member shall be a County Board Supervisor, All members of the Board shall be appointed by the Mayor subject to confirmation by the Common Council. Board members shall be appointed for terms of three-year terms, except the Council Member and County Board Supervisor which shall be for a two-year term.

The position of board members shall be appointed for Mayor Patrick Zielko's years of service to the La Crosso Center Board. This position serves an honorary non-voting board member; shall receive all Information that regular board members of the La Crosso Center Board receive; may attend all board functions; may participate in all discussions related to board matters; shall not fill in as a voting board member wenn other members are absent; and shall abide by the provisions of the sthics ordinance as applicable to regular board members. Attandance of board member ementus at a board meeting shall not be counted toward completing a quorum of the board; attandance at board meetings is optical to the ementus member.

SECTION II: Should any portion of this erdinance be declared unconstitutional or invalid by a court of compoint jurisdiction, the romainder of the articles shall not be affected.

SECTION III: This ordinance shall take effect upon passage and publication.
