Hi Bill,

Thank you for the February 6th letter. Here is my response:

ISG was chosen to provide an independent review of the trail access points and our trail construction documents because they recently worked on a similar project in Winona – the Sugar Loaf trail project. Plus they were able to devote resources now to get us a timely turnaround on our questions.

Next, regarding the traffic sight lines – ISG used a vehicle speed of 30 MPH in their analysis, 5 MPH higher than the posted limit and noted the crest of the hill in their review of the 29th Street access. The minimum sight distances at that speed are 200 feet and the trail access points at both 29th Street and Ebner Coulee Road exceeded the minimums from both directions. The City can definitely consider traffic calming measures on 29th Street in the near future should they be warranted.

Regarding the steepness of the land, wildlife and root systems – attached is a map I received from a constituent with the existing trails marked and some photos. This area is not an untouched wilderness, but includes existing trails that are eroding and causing damage, invasive species, trash and graffiti. As I stated in my earlier response, in recent years the City has invested millions of dollars in habitat restoration, invasive species removal, planting native species and pollinator gardens, fixing old, eroded trails, removing rogue trails and building new, resilient trails. In addition to ORA, we work with the Friends of the Bluffs, Friends of the Marsh, WisCorps and the Mississippi Valley Conservancy to preserve and enhance our natural areas. Adding this area to our work will improve the health of the plant and wildlife species and will reduce damage to the land. We work with many volunteers to complete this effort and I have no doubt that these additional trails and bluff areas can be added to the work load and receive far more attention than they receive now. Our partners help us leverage and stretch the City's limited tax dollars.

Regarding foot traffic and the multi-use aspect of these trails – again, we are working on the details of the trail width, as well as opportunities for hiking only sections of the proposed plan. There will be more to come on this as we continue the review and work on the trail details and site specifics.

Finally, I am not aware of all that goes into a trail building certification, but I have cc'd Kurt Schroeder – ORA president to this reply in case he would like to weigh in.

Hi,

Thank you for the note and comments. I apologize for the time it has taken to respond. As you might imagine, I have received a lot of communication on this project and I am working to get back to everyone. I attempted to address the concerns raised by many of you with this reply.

I begin by offering my apology to you and the neighbors on 29th Street and Ebner Coulee Road for the lack of direct notice on this project. The project was first announced back in 2018 and our staff met with the Bluffside Neighborhood Association on several occasions about the trail project, but we did not reach out to people individually until last month and that was wrong.

I have directed staff to do better in anticipating neighborhood impacting projects and to improve direct communication with those who may be affected going forward. There is always a balance with these types of projects and we should have done better.

I am also sorry if you feel lied to, deceived or that the City has not been transparent. To that end, we have gathered all the project information and will be soon updating the City's website – under "News" – to share the documents, studies and plans.

To address the charge that the City is not listening to you and the neighbors, I offer the following.

During the past several weeks we have received emails, phone calls and face-to-face visits expressing concerns about:

- 1. The safety of drivers, pedestrians and bicyclists at the trail access points on 29th Street and Ebner Coulee Road. In response, the City recently hired ISG an independent engineering firm not associated with the project to review these locations in relation to traffic, parking and safety. The attached report indicates the access points meet (and in most cases exceed) the minimum sight line distances for safe travel. ISG also made recommendations for signage and parking. As we work on the designs and specs of these access points, we will share the plans before they are finalized. We have not worked out the details yet, but I directed staff to hold a public information meeting once we have updated info.
- 2. The soil conditions, slopes and integrity of the bluff. As background, the City has constructed 15+ miles of trails in the recent past on the exact same types of soils and slopes as this project presents. We work with certified trail builders to plan and design the trails, accounting for local conditions and challenges. We also use professional trail builders to construct the trails according to the latest and best practices. In response to these concerns, the City hired ISG to review the construction specifications and standards for this project. The attached report includes their analysis with recommendations. On Page 5 of their report, they stated that "Long-term, high-volume use of similar trails within region have shown that even in soils rated as "severe" for erodibility, with careful management pre, during, and post-construction, erosion is not an issue."
- 3. The need for an environmental impact statement of the bluff before this project should proceed. An environmental impact statement is typically associated with a much, much larger and impactful project, as compared to the trails being proposed. These statements take years to complete and cost hundreds of thousands of dollars. There has not been this need with any of the trails we have constructed previously. In response to these concerns, I offer that the City of La Crosse through our actions has invested millions of dollars into protecting and restoring our blufflands. In the past few years we have removed invasive species, planted native species and pollinator gardens, have repaired old and eroded trails, removed rogue trails and have constructed and maintained new, more resilient trails. We are fully committed to preserving and enhancing the gifts we have been given and take that stewardship seriously. No one wants to see erosion or boulders sloughing off Grandad's Bluff, but the City cannot guarantee that there will never be a problem in the future with or without trails. My belief is that Ellen Hixon gifted this property to the City so that our people could have access to these beautiful areas forever. I do not believe Mrs. Hixon wanted the property sealed off it was a quarry after all and not an untouched wilderness. The trail access points allow for hikers and bikers to

go up and down the bluff more safely. Providing additional access and our continued investments in habitat restoration and maintenance will guarantee future generations can enjoy this land and might inspire more Ellen Hixons to get engaged in environmental stewardship.

4. The narrow width of the trails will be unsafe. In response to this concern, I have directed staff to work with the trail planners and builders to maximize the width wherever safe and practical so that we have a true multi-use facility. This might mean additional changes to the plan and we will keep the community updated on those changes. We also may look at "hike only" portions of the project or designate certain times or days as hiking or biking as this facility gets used and better understood by users, staff and volunteers.

In response to the accusations about the Parks, Recreation and Forestry staff – while there is always room for improvement, I can attest that our staff are dedicated, caring professionals who serve with integrity and compassion. They have completed a significant number of these projects and continue to raise the bar in habitat restoration, management, trail building and maintenance. The health of our bluffs and trails have come a long way in a short period of time due to their expertise and effort.

Unfortunately, our current political climate seems to reinforce the notion that there's a "conspiracy" about this project. That lack of trust in the government may apply at the state and federal level, but I do not believe it is the case with our local government. We are all trying to do our best for the 52,000 residents who live here and the countless tourists who visit. I know I have learned a lot about these concerns and we are committed to making this a successful and safe project.

My hope is to continue the dialogue with you – especially as we begin to work on the details.
