## GRAZZINI BROTHERS & COMPANY Terms & Conditions For Proposal

- A. Job Conditions Assumed in Proposal. Unless otherwise expressly provided for in this proposal, to which these items and conditions are a part, Grazzini Brothers & Company (GBC) has based its proposal price upon the Owner/Contractor furnishing at its expense the job conditions listed below. The job conditions are as follows:
  - 1. **Transportation Conditions**. Direct access to the working area by truck to and upon a clear, welldrained site over an all-weather, hard surface road.
  - 2. Labor Conditions. Working periods of eight hours per day and 40 hours per week under normal working hours. <u>No overtime or weekend work included</u>.
  - 3. Working Conditions. Safe and clean working conditions in compliance with federal, state, and local safety, environmental, and air pollution laws and ordinances. Stairways and/or elevators, with a minimum 3,000 pound capacity and minimum door opening of 48 inches for access to building for delivery of materials, tools, and equipment, to be provided by Owner/Contractor at no charge or inconvenience to Grazzini Brothers & Company.
  - 4. **Site Utilities**. Available water, sanitary facilities, and electric power (220 volt/ 50 amp single-phase and 110 volt <u>service and connections</u>) within 100 feet of GBC's work area.
  - 5. **Heat Conditions**. Heat maintained at 50 degrees Fahrenheit minimum temperature at floor level in any enclosed facilities in which GBC's work will be performed. At GBC's sole discretion, materials may not be applied in unenclosed areas at temperatures less than 50 degrees Fahrenheit, nor in excessive humidity, nor in high wind, heat or rain.
  - 6. **Surface Preparations and Clean-Up Conditions**. Prior to, during, and after GBC's performance of GBC's work, the Owner/Contractor without delay or interference with GBC's work, shall:
    - a) Remove from all surfaces to be covered all contaminants such as oil, grease, chemicals, dirt, applied coatings, sealers or compounds, and debris, together with other obstructions which interfere with GBC's performance of its work.
    - b) Performing all grinding and patch work including leveling all low and high spots to prepare or maintain a smooth, level surface.
  - 7. **Debris Removal**. Provide a disposal system at no cost to GBC in which GBC will deposit its debris for removal from the site by the Owner/Contractor.
  - 8. **Protection of Work**. Owner/Contractors shall protect and be responsible for GBC's finished and inprocess work from fire and physical damage.
  - 9. Notification and Mobilization for Commencement of Work. The Owner/Contractor will give Grazzini Brothers & Company at least <u>seven (7)</u> days advance written notification of the date upon which the Owner/Contractor desires GBC to commence work.
  - 10. **Stored Materials**. The Owner/Contractor will provide an appropriate, accessible, and secure area to store materials.
  - 11. **Payment Terms**. GBC shall invoice the Owner/Contractor monthly for labor and materials furnished during the preceding 30 days. Invoices shall be paid by the Owner/Contractor within 15 days after submission. No retainage shall be withheld from payments unless previously agreed in writing in this proposal. Payments withheld by the Owner/Contractor shall bear interest at the rate of 18% per annum from date due. All materials which require prepayment to the supplier will be paid immediately upon request.
  - 12. Arbitration. All claims, disputes, and other matters in question between GBC and the Owner/ Contractor arising out of or relating to this contract or the breach thereof shall be decided by arbitration. Either party may demand arbitration by written notice to the other. The rules of the Minnesota Uniform Arbitration Act shall be specifically followed. All arbitration proceedings shall be held in Minneapolis, Minnesota.
  - 13. **Changes**. A signed order must be received by GBC from the Owner/Contractor prior to commencing work on any changes to the work. No changes to the work will be made without signed orders, prior to commencing any work.
  - 14. Warranties. Our installations are warrantied for one year from substantial completion. In the event repair or replacement is deemed necessary for any non-conforming work GBC shall have the first opportunity to remedy.
