NOTICE IS HEREBY GIVEN that the Common Council of the City of La Crosse, by its Judiciary & Administration Committee, will hold a public hearing on a proposed ordinance change in the zoning code as follows:
AN ORDINANCE to amend Sub-section 115-110 of the Code of Ordinances of the City of La Crosse transferring certain property from the Public/Semi-Public District to the Single Family District allowing single family homes at 5215 and 5235 Creekside Place.
Property is presently used for: Vacant land.
Property is proposed to be used for: Three single family homes.
