AN ORDINANCE to amend Section 2-604 of the Code of Ordinances of the City of La Crosse changing the composition of the La Crosse Center Board.

THE COMMON COUNCIL of the City of La Crosse do ordain as follows: SECTION I: Section 2-604 is hereby amended to read as follows: Sec. 2-604. Membership and organization.

The Le Crosse Center Board shall consist of ten members who shall be qualified efectors or residents of the City, except that if the Mayor appoints a representative of the Le Crosse County Convention and Visitors Bureau to the La Crosse Center Board and given member that is a City of La Crosso business owner, those their appointees need not be a resident of the City of La Crosso Lamburgh that is a City of La Crosso business owner, those their appointees need not be a resident of the City of La Crosso. One member shall be a Council Member and one member shall be a County Board Supervisor. All members of the Board shall be appointed by the Mayor subject to confirmation by the Common Council, Beard members shall be appointed for three-year terms, except the Council Member and County Board Supervisor which shall be for a two-year term.

The position of board member emittus is hereby cousted for Mayor Patrick Zicklo's years of service to the La Crosse Center Board. This position serves an honorary non-voting board member; shall receive all information that regular board members of the La Crosse Center Board receive; may stend all board functions; may participate in all discussions related to board matters; shall not fill in as a voting board member when other members are ebsent; and shall adde by the grovisions of the ottics ordinance as applicable to regular board members. Attendence of board member emention at a board meeting shall not be counted toward completing a quarum of the board; attendance at board meetings is optioned to the emeritus member. SECTION III: Should any partion of this ordinance be declared to the article shall not be affected.
