This proposal includes the following:

- Mobilization from our La Crosse, WI office.
- Proposed work schedule: Five (5) work days, Monday through Friday, 10 hour shifts and no holiday work. Weekend and Holiday work hours can be provided if requested.
- Repair includes
- Excavating down 0-3' of material to expose damaged section of 12" CMP
- Remove and replace 12" diameter CMP starting at the approx. 113' mark proceeding west to river approx. 10', a coupler band will be used to connect the new section to the existing pipe
- Remove the existing concrete end support and tree, and dispose of both. Install new end outlet/ end secion above the water.
- Install fabric/riprap around the new end outlet and backfill the new pipe with the existing bank material.
- Install seed and erosion mat on non-riprap areas
- Equipment and material access assumed via barges

This proposal excludes the following:

- Working with any hazardous materials
- Permits, licenses, bonds, permits or fees of any kind
- Sheet pile installation or any efforts to stabilize/protect/replace the existing bank or landowner retaining walls, etc. Excavation assumed no deeper than 3'. If bank slope becomes or appears to be unstable, Brennan will halt work and revise new scope with City.
- Utility relocation or protection
- If applicable, this proposal assumes all work will not be subject to/performed under the National Maintenance Agreement. This proposal assumes work performed under local heavy highway or general building union agreements.
- -This proposal and scope of work must be fully incorporated in any contractual agreement and is to take precedence over any conflicting terms and agreements embodied in any other agreement or documents.
