A few years ago when we received 18" of snow over night I arrived home after working an overnight shift at 8:00am to our street being unable to drive down due to the amount of snow and the plows starting on intersecting streets. There were cars stuck all over due to being plowed in and cars stuck in the middle of the street. People were out digging out cars and trying to clear all the snow. I could not safely drive down my street. I drove down Jackson Street and saw Taco Johns Parking lot plowed and decided I would park my car there in the farthest parking spot while I waited for the plows to come down our street. As I got out of my car after leaving
