### CONTRACT AGREEMENT LARGE ITEM COLLECTION/SPRING CLEAN UP

This agreement entered into this 15<sup>th</sup> day of February, 2021, by and between Harter's Quick Clean-Up, Inc hereinafter known as "CONTRACTOR" and the City of La Crosse, Wisconsin, a Municipal corporation, hereinafter known as "CITY". Contractor

WITNESS, the Contractor and City for the consideration herein agree as follows:

#### SCOPE OF SERVICES

The Contractor shall provide all equipment, provide authorized and qualified labor to perform and complete in a professional manner.

- Collection of large items shall be on the same day as recycling collection. The intent is for one (1) complete pass through the City.
- Collection of large items to be landfilled shall be done with a rear end packer truck.
- Collection vehicle for mattress and box springs is at the discretion of the Hauler, but mattresses and box spring shall be covered during collection if incumbent weather to ensure materials stay dry.
- Large items collected shall be limited to five (5) per tax parcel. An example: a dining table and chairs count as one (1) item.
- Appliances and electronics banned from landfill shall not be collected.
- Contractor shall haul and dispose of non-recyclable material removed from properties at the La Crosse County Landfill. The City shall reimburse the contractor for disposal fees and tipping fees based on weight tickets from the La Crosse County Landfill.
- All metal that can feasibly be recycled, shall be. Any revenue received by the contractor shall be retained by the contractor.
- All mattresses and box springs shall be recycled (not refurbished) by a licensed facility. No mattress or box spring shall be landfilled unless previous permission has been granted by the Recycling Department. The City shall reimburse the contractor for recycling fees based on tickets from the recycling facility.
