2656 - An appeal regarding the regulation limiting the number of garages to one, and the requirements that an accessory structure cannot exceed 17 feet in height from the finished floor, the accessory structure wall height cannot exceed 10 feet in height, and the garage door height cannot exceed 8 feet in height at a property known as 1524 Island Street, La Crosse, Wisconsin. Referred from March 15, 2021 meeting.
