Stacia Goodman Mosaics Will:

DURING CONTRACT PHASE:

• Provide Artist's 2 legal documents: 1) Terms of Service, and 2) Commissioning Art Agreement.

• Work with client to sign final legal documents.

DURING DESIGN PHASE:

- Collaborate with Ho Chunk artist or student on Heron's wing design.
- Provide final color concept for approval to proceed.

DURING FABRICATION PHASE:

- Fabricate mosaic artwork.
- Provide status photos at key milestones (typically, at one-third intervals).
- Deliver artwork for installation.

DURING INSTALLATION PHASE:

• Install artwork using onsite lift provided by convention center.

ONGOING:

• Participate in any community engagement and publicity opportunities, if available and with advance notice.

Client Will:

- Sign Artist's 2 legal documents: 1) Terms of Service, and 2) Commissioning Art Agreement.
- Provide consolidated final approval of design for Artist to proceed to fabrication.
- Provide name and contact info for Ho Chunk for design collaboration.
- Clear and prepare site for artwork installation.
- Provide use of the Convention Center's onsite electric lift, power source and water.
- Provide and install a nameplate for the artwork within 3 months of installation.
