Dear Council Member Kiel,

Hello, my name is Kristie Neve, I reside at 417 S. 21 St. I am a registered voter in District 7.

Over the last months, I have looked into the rezoning proposal regarding the Hatchery at Riverside Park, from a public to a private/public enterprise. I have talked to my neighbors regarding this issue. You will find a homegrown petition along with this letter. Several of my neighbors have signed who are opposed to the Hatchery's goals of becoming a commercial venue for booking wedding parties; having an outside beer garden, AirBnB rooms, and other suggested pop up markets. The Park Board has made clear that this building needs rezoning for this project to continue.

I attended the last Council Meeting (August 12, 2021) where rezoning was on the Agenda. As a matter of fact, I was one of folks at the meeting who expressed my concern over the rezoning. I was grateful that a pause was placed on the rezone vote. After attending a Park Commissioners' Board Meeting and a public comment program at the Southside Community Center, I still remain firmly against the city leasing this building to the newly formed company, The Hatchery, LLC. I ask what is their track record with such projects? Has the City Council carefully reviewed the company's proposal and business model? I just don't feel there has been adequate due diligence.

When will the beer garden be open? Initially, I heard that it as only when a party was being held and for the attendees only. I got the impression recently that this beer garden could be open at different times and for anyone. What will be the status of this proposed outside beer garden? The city has a problematic history with intoxication and the river. We need to find ways to reduce that opportunity, not encourage it.

Finally, there are significant problems with traffic and parking. The Park Board has not sufficiently explained how there will be ample space around the building for parking and smooth traffic flow, and all those vehicles detract from the experience of park visitors. From my perspective, that corner of the park can become congested, not to mention the inconveniences for residents at the adjacent apartment complex and the folks who visit the International Friendship Garden.

I would gratefully appreciate your consideration regarding the issues I have brought up. The neighbors who signed my petition have generously permitted me to express, for them, the concerns that I have presented.
