Nichols attended Waste or Resource Management (WoRM) conference in Oconomowac with interns. He is working on dealing with oversized waste with Xcel Energy to prevent burning problems at the plant. George Howe, director of Mysteries of the Driftless, attended Green Drinks. Nichols will host an 2014 Indicators Report working meeting on Tuesday, April 27th at noon. Landfill will host North American Squirrel Association (NASA) and DNR for handicap hunt. Nichols led many tours of the landfill and presentations at Enviro Wednesday at Myrick Park, ORA summit, and Earth Fair at Myrick Park. Xcel will get their two millionth ton of refused-derived fuel soon. The landfill recieved a Vision Award from the Gateway Area Council of the Boy Scouts.
