4 Staff Reports and Informational Updates

Jason Gilman provided an update on the progress MSA is making on the 2015 Indicators report, noting key findings so far and that the information will be presented to the Council Planning Session July 12, 2016.

5 Community Solar Gardens Program - Mike Herro, Xcel Energy

Alex Lueck from Xcel energy was in attendance on Mike Herro's behalf. Mr. Lueck provided an overview of Xcel Energy's solar initiative in Western Wisconsin:

2-1MW gardens planned-1 in La Crosse and 1 in Eau Claire

Each solar garden is about 8 acres in size

There are 800 customers signed up for the program so far

Each garden allows for a subscriber to receive energy credits on their energy bill,

without the burden of constructing and maintaining an individual system

There are 3,225 panels in each garden, with each panel creating 310 watts of energy

The solar gardens are expected to be operational in early 2017

The solar subscriptions range from 200 watts minimum to 400 kilowatts maximum

There is a 1 time enrollment cost to subscribe

The cost of enrollment is \$1,780 per 1kw, with a \$200 deposit per kw.

A energy bill credit is given to subscribers of 7.4 cents per kw hour for residential and

6.9 cents per kw hour for commercial

6 Consideration of Sustainability program goals for fiscal year 2017

The chair encouraged the committee to bring ideas for 2017 goals forward at the next meeting in July.

7 Review City of Madison's Demolition Recycling and Reuse Plan

The chair noted this item was introduced by Habitat for Humanity and will be considered at the next meeting in July.
