Mike Ferris reported on four (4) of the conventions that booked since the last board meeting which included two events for the Institute for the Study of Human Awareness and the JDRF Ride, all in 2017 and the Minnesota- Wisconsin Public Transit Conference in 2018. The Center now has 25 conventions booked for 2017 compared to 19 for 2016.

5 Financial Report for 2016 and YTD

Director Fahey reported that the YTD through July 31, 2016 the Center was \$145,999.53 in the black. This compares to the same period one year ago of being \$94, 348.18 in the black. For the month of July 2016 the venue was \$34,192.82 in the red compared to \$57,152.32 in the red for July 2015.
