Kelly Branson reviewed the CPC changes and the department head changes that allowed the budget to meet the goal of not to exceed \$8 million new borrowing. Mayor Tim Kabat acknowledged the totals on page 12 versus years past and noted how challenging it can be to determine what will remain in the budget, while also noting that this year's high total is mostly due to the approximately \$75,000,000 DOT exit 3 project. He also noted that the CIP budget does not include the La Crosse Center. Mayor Kabat invited members of the public or city staff in the audience to provide comments.

A motion was made by Commissioner Randy Turtenwald, seconded by Council Member Cherf, to move out item 105 to 2018. The motion carried by voice vote. A motion was made by Commissioner Randy Turtenwald, seconded by Council Member Cornett, to move out item 273 to 2018. The motion carried by voice vote. A motion was made by Commissioner Randy Turtenwald, seconded by Council Member Cornett, to move out item 274 to 2018. The motion carried by voice vote. A motion was made by Commissioner Randy Turtenwald, seconded by Council Member Cornett, to move out item 285 to 2018. The motion carried by voice vote. A motion was made by Commissioner Randy Turtenwald, seconded by Council Member Cherf, to add a water main on 22nd St from Jackson to Johnson totaling \$65,000 with the source of funding equals 2. The motion carried by voice vote. A motion was made by Council Member Cherf, seconded by Council Member Cornett, to delete item 250. The motion carried by voice vote. A motion was made by Council Member Cornett, seconded by Council Member Becker, to move item 41 up to 2017 from 2018. The motion carried by voice vote. A motion was made by Council Member Becker, seconded by Council Member Cherf, to direct the Mayor and staff to identify the approximately \$70,000 of new borrowing that can be cut so as not to exceed \$8 million new borrowing. A motion was made by Commissioner Tischer, seconded by Council Member Cherf, to move out item 86 to 2018. The motion failed because of a tie vote with Tischer, Becker, Cherf and Schoenfeld voting in favor.

A motion was made by Council Member Becker, seconded by Council Member Cornett, to allow Kelly Branson to round up to nearest \$5,000 as per borrowing rules without exceeding the \$8 million new borrowing. The motion carried by voice vote. A motion was made by Council Member Becker, seconded by Council Member Cornett, to approve the budget as amended, which includes the changes made today and the directive to the Mayor and staff to remove approximately \$70,000 of new borrowing to meet overall goal. The motion carried by voice vote.
