6 Recycling Forum @ 5:30 pm

Henry Koch presented on La Crosse County's Solid Waste Facility. Recycles 1-7 plastics; don't need to separate mixed plastics, but do need to separate out plastic bags and film; shredded paper needs to be separated in a bag; added aseptic cartons and wax paper cups (including take out containers); whole-stream recycling not necessary at this point; composting not covered. Harter's Quick Clean Up is converting to natural gas and doing more local processing, including optical sorting for plastics and electronic recycling; does paper shredding at Earth Fair. Curbside pick-up improves recycling rates for rural residents (ex: Holland). 7 Rivers Recycling recycles mattresses, including upcycling for weed barriers.

Ideas include: garbage fairy to reward good job, more educational materials about what is recyclable, videos online to show process (could work with television stations), more bins instead of more frequent pick-up, keep an eye on emerging technologies, and sharing plans for extending list of recyclables.
