Meeting Minutes

Neighborhood Revitalization Commission

Call to Order, Roll Call

The meeting was called to order by Mayor Kabat at 6 p.m.

Approval of Minutes

A motion was made by Trost, seconded by Haavind, to approve the April 3, 2017 meeting minutes. The motion carried by voice vote.

Agenda Items:

1. Karl Green, UW Extension, presentation on neighborhood data

> Karl Green's powerpoint presentation was distributed to members the day of the meeting. He noted that La Crosse has the lowest total tax base (personal, manufacturing, commercial, residential) compared to other comparable cities in Wisconsin. All cities saw some drop in the equalized value per capita of between 2009 and 2015. Compared to other cities, towns and villages in the County, the City of La Crosse has stalled out in total residential equalized value/capita. The City has a low number of \$200,000 houses, which impacts the tax base. La Crosse has affordable homes in the \$100,000-\$150,000 range. The County median house value is \$154,600. Karl showed the percentage increase in value between 2012-2016, demonstrating that many villages and towns are before even the first City neighborhood. He then noted the most troubled neighborhoods also have the highest percentage of rentals and not changing ownership. For the purposes of his presentation, owner occupancy was determined by lottery tax credit. He also demonstrated the property statistics by school district, noting a 10 year trend in disruptions, or students leaving the school mid-year. The whole school spends more time acclimating students and therefore there is more instability in the whole student body. Karl noted La Crosse has a 34.3% change in daytime population, noting the high number of commuters. Finally, Karl noted the City of La Crosse has the lowest residential value per capita in the entire county; there is very little value, but as much demand for services.
